- Completed entry form and fee must be submitted to the Telfair County Chamber of Commerce by October 25, 2019, 12 p.m.; (Telfair County Chamber of Commerce: 9 East Oak St. McRae-Helena, GA 31055)
- Entry Fee-\$10 per team; Entry fees are non-refundable
- Businesses may enter multiple teams.
- Submit an entry form for each team entered into the contest.
- Costumes cannot display vulgar, obscenities, or displays.
- Judging will begin on October 31, 2019 at 9 a.m. and end at 5 p.m. The Chamber will notify business of the their scheduled judging time after Chamber has received the business entry form.
- There will be only one category in which to compete: COSTUMES.
- Costumes will be judged on:
 - ◊Group Participation
 - ◊Originality/Uniqueness
 - ◊Creativity/Resourcefulness
 - ◊Related to Past Prominent Residents or related to Rural Telfair.
 - ◊Overall
- There will be no individual awards; only TEAM AWARDS;
